6.1 Interdistrict Attendance Transfer Agreement

Jennifer related her conversation with the Superintendent of McKInleyville Union School District.

MUSD will need to be assured that any students seeking transfers out of the district participate in the enrollment strategy efforts of that district if they submit the permit after the February 1<sup>st</sup> deadline. Jan Schmidt, the current superintendent, will be retiring at the end of this school year. Currently, eight students attend Big Lagoon School who are McKinleyville residents. Four students who are residents attend McKinleyville Union Schools.

Recommendation to Approve

Sara Demetroff, the representative from Greenway that worked directly with Big Lagoon, has resigned from Greenway. Jennifer has been in contact with Matt Grosjean, one of the partners. PG & E is still interested in offering \$99,000 for the completion of the ZNE project. It is limited in scope from the original project that Greenway proposed; it includes the installation of fewer HVAC pumps and does not allow for the dismantling nor removal of the diesel tank.
