## California Healthy Kids Survey Administered in Fall 2005

Districts who receive federal Title IV funding through the No Child Left Behind Act (NCLB) are required to administer the California Healthy Kids Survey (CHKS) every two years. For many districts in Humboldt County, that will take place in Fall 2005, and now is the time for districts to prepare.

The CHKS is a questionnaire completed every other year by students in grades 5, 7, 9 and 11 and in alternative education schools. The survey asks students about their health-related behaviors and decisions and about the external supports and personal skills -collectively called "assets"- that promote positive youth development and help prevent unsafe or unhealthy behaviors. Student participation in the survey is voluntary, anonymous and confidential.

One of the greatest challenges to completing the survey is getting parental permission. Changes in state law offer the new option of using passive parental consent at grades 7, 9, and 11, rather than active (written) consent as was previously required. To do so, the

school board must formally adopt a passive consent policy, and parents/guardians must be notified in writing at the beginning of the school year and given a reasonable opportunity to review the survey and opt out. Districts may still choose to use active parent permission. In either case, parent information should be included in the back-to-school packets. When using active consent, most districts find it easiest to put the parent permission form in the back-to-school packet and require a signature (either granting or denying permission) as part of the back-toschool procedures.

The next step is to designate a coordinator for the survey administration. That person will want to visit the WestEd website at www.wested/hks. Links on the homepage will lead to information on signing up for the survey and completing the MOU with WestEd. A guidebook for administering the survey is found in the *Tools* section. This includes useful timelines and check lists.

An online web-based School Climate Survey, which collects information from teachers, is now also a required part of the CHKS.

#### Chew/Dip Tobacco Use Increases Risk of Pancreatic Cancer

Dr. Paolo Boffetta from the International Agency for Research on Cancer in Lyon, France, and his colleagues analyzed data from more than 10,000 Norwegian men, and reported that the risk of pancreatic cancer was 67 percent higher among men who ever used smokeless tobacco than among men who never used smokeless tobacco.

Overall, smokeless tobacco doesn't seem any safer than the smoking tobacco. The study couldn't determine if the risk of pancreatic cancer increased in step with the amount of smokeless tobacco used.
